### What is the SEN Information Report?

The SEN Information Report provides information to questions parents may ask about the school in terms of identifying needs, raising concerns, parental involvement and how Priddy & St. Lawrence's C of E Primary Federation can support and provide for a child with SEND.

Priddy & St. Lawrence's C of E Primary Federation is an inclusive school. We strive to support all children to enable them to achieve their full potential. In order to do this, many steps are taken to support them through their learning journey. High quality teaching is essential, however, for some children there are occasions when additional support may be needed to help them achieve and progress.

The Government introduced new SEND (Special Educational Needs & Disability) reforms to schools that came into effect in September 2014, now known as the 'Children and Families Bill'. The reforms aim to streamline support for children and young people aged 0-25 and focus on delivering positive outcomes for them.

The Somerset Graduated Response Tool outlines the barriers to learning that children may have and suggests strategies that could be implemented to support these individuals. We use this tool in our school to help us plan appropriate provision for our young people and be able to measure progress accordingly.

We also have developed our graduated response documents in line with the Somerset Graduated Response Tool, with our provision map reflecting what support we can currently offer in school relating to each of the four broad areas of need. This is regularly reviewed and updated to reflect changes and developments in the level of provision we have available.

### The different areas of SEND and related difficulties:

The SEND Code of Practice (2014) states that there are four main areas which cover Special Educational Needs.

These areas and their meanings are as follows:

<p style="text-align: center;"><b>Communication and Interaction</b></p>	<p>Children may have a delay or difficulty in one or more of the following areas:</p> <p><b>Attention / Interaction skills:</b> may have difficulties ignoring distractions. Need reminders to keep attention. May need regular prompts to stay on task. Difficulty attending whole class learning. May have peer relationship difficulties. May not be able to initiate or sustain a conversation.</p> <p><b>Understanding/Receptive Language:</b> may need visual support to understand or process spoken language. May require assisted technology to help them communicate. Frequent misunderstandings. Repetition of language and some basic language needs to be used to aid their understanding.</p> <p><b>Speech/Expressive Language:</b> may use simplified language and limited vocabulary. Ideas/conversations may be difficult to follow. Some immaturities in the speech and sound system. Delayed grammar/phonological awareness.</p>

		<ul style="list-style-type: none"> <li>• Using and drawing up learning passports and Assess, Plan, Do, Review (APDR) plans for children with SEND. APDR plans have individual targets, these are very specific to the individual child and may be small steps, working towards a bigger overall target. These will be discussed with you and your input for creating these targets is very much encouraged.</li> <li>• Identify when additional support is needed.</li> <li>• Ensuring that all staff working with your child are supported to deliver planned work so that they can achieve the best possible progress. This may involve the use of additional adults (support assistants). The SENDCo will work with the teacher to ensure all staff are fully skilled to work with children with SEND.</li> <li>• Ensuring the SEND Policy is followed in their classroom.</li> </ul>

Knowing when extra help is needed and identifying SEND

Knowing when extra help is needed and identifying SEND	
Question	
How does the school know if my child needs extra help?	<p>There are a variety of ways of knowing if a child needs extra support, all children are monitored daily. Some of these ways of knowing if a child needs additional support may be through:</p> <ul style="list-style-type: none"> <li>• Day to day work in class, observing the child, talking to the child about their difficulties</li> <li>• If lesson objectives are being achieved</li> <li>• If a child is performing below age expected levels</li> <li>• Concerns raised by a parent/carer, child or the teacher</li> </ul> <p>Teachers will discuss any concerns with you, including if it may be a self-esteem issue. Additional support, quite often, can be a short-term boost to get them back on track.</p>
How do they identify SEND?	<p>Again, it would be similar to above, but may also involve:</p> <ul style="list-style-type: none"> <li>• Liaison with external agencies (with carer/parental permission)</li> <li>• Diagnosis (possibly from a health professional, i.e. paediatrician, visual/hearing services)</li> <li>• Liaison with Pre-school/previous school</li> <li>• The child may be significantly below age related expectations academically - please note that not all SEND may affect academic abilities - i.e., some physical difficulties.</li> <li>• Specific assessments by the SENDCo (alongside teacher assessments).</li> <li>• Discussions/observations.</li> <li>• Outcome of Wave 2 (booster group) additional support intervention.</li> </ul>
<p>What should I do if I think my child may have Special Educational Needs &amp; Disabilities (SEND)?</p> <p>Who do I raise my concerns to?</p>	<p>Class teacher</p> <p>SENDCo</p> <p>Head teacher</p> <p>Come into school and talk to us!</p> <p>The first point of contact is your class teacher. You know your child better than anybody and by working together we can build up an overall picture of your child's needs.</p> <p>We take pride on building positive relationships with parents/carers. We are open and honest with parents/carers and hope that you feel comfortable by being so with us too. Your view is very much valued and important to us.</p> <p>Miss Smout is happy to meet with you and your child's class teacher to look at how we can best support your child.</p>

If you still have concerns following discussions with the class teacher and SENDCo, the head teacher is also another point of contact. If you remain unhappy and feel that the situation has not been resolved, please refer to the Complaints Policy.

<p>What are the different types of support available for children with SEND in this school?</p>	<p>Class teacher input via excellent targeted classroom teaching, also known as High Quality First Teaching (wave 1).</p>	<ul style="list-style-type: none"> <li>• Ensuring that the teacher has the highest possible expectations for your child and all the pupils in the class (so they can reach their full potential).</li> <li>• Ensuring that all teaching is based on building on what your child already knows, can do and understands.</li> <li>• Putting in place different ways of teaching so that your child is fully involved in learning in class. This may involve things like more practical learning etc.</li> <li>• Putting in place specific strategies (which may be suggested by the SENDCo or outside staff) to support your child's learning.</li> <li>• Inclusive Dyslexic Friendly Teaching (benefits all children not just those with Dyslexia).</li> </ul>	<p>All children in school should be getting this as a part of excellent classroom practice.</p>

	<p><u>Specific</u> group work (wave 2) with a smaller group of children. This may be:</p> <ul style="list-style-type: none"> <li>- Taught in or outside of the classroom</li> <li>- Lead by the teacher or another member of staff who has had guidance/training to run these groups.</li> </ul>	<ul style="list-style-type: none"> <li>• Your child's teacher will have carefully checked on your child's progress and will have decided that your child has gaps in their understanding/ learning and needs some extra support to help them make the best possible progress.</li> <li>• He/she will plan group sessions for your child with targets to help your child to make progress.</li> <li>• A learning support assistant/teaching assistant (LSA/TA) may run these sessions using the teacher's plan and under their guidance.</li> <li>• Some group work may be planned by the SENDCo. If the LSA (learning support assistant) is to run these sessions, again, it will be under the SENDCo's plans and guidance.</li> </ul>	<p>Any child who has specific gaps in their understanding or a subject / area of learning.</p> <p>This may be a 'booster group' with children who are not on the SEND register.</p> <p>Or it may be for children with SEND and linked to their individual targets (on their pupil passport and APDR document), who have a slightly higher level of need and difficulty. Children at this stage (relating to the Code of Practice) will be under 'SEND Support'.</p>
	<p>Individual support (Wave 3)</p>	<ul style="list-style-type: none"> <li>• Your child will have been identified by the class teacher/SENDCo (or you may have raised concerns) as needing more specialist input instead of, or in addition to, intervention groups or work within class. This may be following a literacy/numeracy programme on a 1:1 basis for 3 times a week (30 min etc). The member of staff will be under guidance from the teacher or SENDCo and may also have specific training relating to the programme.</li> <li>• Your child's progress will be discussed with you and ways of moving them forward.</li> <li>• You may be asked to give your permission for the school to refer your child to a specialist professional e.g. Speech and Language Therapist or Educational Psychologist. This will help the school and yourself understand your</li> </ul>	<p>Children with specific barriers to learning that cannot be overcome through Quality First Teaching and intervention groups.</p> <p>Children at this stage (relating to the Code of Practice) will be under 'SEND Support', it will also be noted if they have additional professional support.</p>

		<p>child's particular needs better and be able to support them better in school.</p> <ul style="list-style-type: none"> <li>• The specialist professional will work with your child to understand their needs and make recommendations, which may include: <ul style="list-style-type: none"> <li>- Making changes to strategies to how they are supported / taught in class.</li> <li>- Set targets which will include their specific expertise.</li> <li>- Group/individual programme under the guidance of the outside professional.</li> </ul> </li> </ul>	
	<p>Specific individual support (usually of more than 20 hours in school).</p> <p>Usually your child will also need specialist support from a professional outside the school. This may be from:</p> <ul style="list-style-type: none"> <li>- Local Authority services.</li> <li>- Outside agencies such as the Speech and Language Therapy Services.</li> </ul>	<ul style="list-style-type: none"> <li>• The school (or you) can request that the Local Authority carry out a statutory assessment of your child's needs. This is a legal process which you can find out more from the Local Authorities 'Local Offer' (or speak to your SENDCo). After the school has sent in a lot of information about your child, including some from you, they will then decide if the child's needs are complex enough to carry out a full assessment. If so, more information/reports will be gathered from various professionals (which would usually already be involved with the child's needs). The authority will then review the case again and decide if an EHCP (Educational, Health Care Plan) needs to be written.</li> <li>• The EHCP will outline the number of hours of support your child will receive from the LA (local authority) and how that support should be used and what strategies must be put in place. It will have long and short term goals for your child.</li> <li>• Additional funding will come with an EHCP, which will help top up schools extra financial input.</li> </ul>	<p>Children whose needs are severe and complex and often need more than 20 hours support a week in school. These needs may also be lifelong.</p> <p>In the Code of Practice they will have a EHCP 'Educational, Health Care Plan' (if this is agreed and written up by the authority). This means your child will have been identified by the class teacher and SENDCo as needing a particular high level or individual or small group teaching (more than 20 hours per week), which cannot be provided from the budget available to the school.</p>

		<ul style="list-style-type: none"> <li>• Funding may be spent in various ways, however best to meet your child's needs - i.e. LSA, equipment, training etc.</li> <li>• If required, the child may also attend support off school site at a specialist unit or be part of a dual placement with a Special School.</li> </ul>	
How is extra support allocated to children and how do they move between the different category in the Code of Practice?		<ul style="list-style-type: none"> <li>• The school budget, received from Somerset County Council (local authority), includes money for supporting children with SEND.</li> <li>• The head teacher decides on the budget for special education needs in consultation with the school governors, on the basis on needs within the school.</li> <li>• The head teacher and the SENDCo discuss all the information they have about SEND in the school including children who need or are getting support and children who are not making expected progress. They then decide what resources/training are needed. This is reviewed regularly.</li> </ul> <p>It will also depend on your child's level of need and how they manage in school. Also strategies, interventions will be monitored for their impact and effectiveness. We may need to refer to get outside support and their perspective on how best to meet your child's needs and how to help them reach their full potential. For some more higher level of needs, additional funding will be needed due to extra costs involved in supporting your child (through an EHCP). It really does depend on the complexity of the child's needs.</p>	

### Making Progress and Concerns

Making Progress and Concerns	
Question	
How will you measure the progress of my child in school?	<ul style="list-style-type: none"> <li>• Your child's progress is continually monitored by his/her teachers and the head teacher.</li> <li>• His/her progress is reviewed formally every half term using the National Curriculum bands and tracked on the school tracking systems.</li> </ul>

	<ul style="list-style-type: none"> <li>• If your child is working below the 'first' (year 1) band then your child can be assessed using another scale. These levels are called the 'PKS standards (pre-key stage)'. They are a set of level descriptors that can be used to assess/ measure progress.</li> <li>• Children on the SEND register will have a learning passport and APDR plan. These will set out your child's individual targets, strategies that will help them and the criteria for achieving these targets. These will be reviewed at least 3 times a year.</li> <li>• The progress of children with an EHCP is formally reviewed at an Annual Review with key adults involved within the child's education being invited.</li> <li>• The SENDCo will also check that your child is making good progress within any individual/group work and collect data during discussions with the staff member running the support on a half termly basis.</li> </ul>
<p>How will the school let me know if they have concerns about my child's learning?</p>	<p>When a teacher or a parent/carer has raised concerns about your child's progress, and targeted teaching has not met the child's needs, the teacher must raise this with the head teacher and SENDCo (often at termly progress meetings).</p> <p>If your child is identified as not making progress the school will set up a meeting to discuss this with you in more detail. This will also be a time to listen to any concerns you may have, plan any additional support and consider with you a referral to outside professionals for their advice (if needed).</p>

The Curriculum

<p>How will the teaching be adapted for my child with learning needs (SEND)?</p>	<ul style="list-style-type: none"> <li>• Teachers plan lessons according to the specific needs of all groups of children in their class and will ensure that your child's needs are met. Work will be differentiated to suit the ability of each child.</li> <li>• Support staff will support with your child's learning in the classroom.</li> <li>• Specific resources and strategies will be used to support your child individually and in groups.</li> <li>• Planning and teaching will be adapted on a daily basis if needed to meet your child's learning needs.</li> </ul>

<p>How are teachers in school supported to work with children with SEND and what training do they have?</p>	<ul style="list-style-type: none"> <li>• The SENDCo is able to support the teacher in planning for children with SEND.</li> <li>• The school has training opportunities for all staff to improve the teaching and learning of children including those with SEND. This may also include whole school training.</li> <li>• Individual teachers and support staff attend training courses run by outside agencies that are relevant to the needs of specific children in their class.</li> <li>• The SENDCo attends various cluster meetings, conferences and courses throughout the year.</li> <li>• Examples of expertise within the school include: <ul style="list-style-type: none"> <li>- ELSA (Emotional Literacy Support Assistant) - support for emotional well-being.</li> <li>- Autism training</li> <li>- Speech and Language training.</li> </ul> </li> </ul>
<p>How will my child be included in activities outside the classroom including school trips?</p>	<p>We are an inclusive school and will make sure all children are given the option to take part in school trips, whatever their need(s). All school trips will have a risk assessment completed prior to the trip. Some children with a higher level of need may also have their own individual risk assessment too. Staff involved in the trip will have carefully planned and considered what may need to be adapted, what they need to be aware of and any other factors which will affect your child. Information/letters will be sent home about any trips and in some cases we will have a meeting to also discuss the details with you in person, so to make sure your child has a positive experience and gets a fulfilling learning experience from it!</p>
<p>Will he or she be able to access all of the activities in school and how will you help him or her to do so?</p>	<p>We aim to provide an inclusive learning environment to support all our children whether they have exceptional abilities and talents or face particular challenges in their learning, or have medical or emotional needs. Certain activities may be differentiated or adapted so they can access it at their level. All activities are planned and making sure all children can be fully involved is essential and carefully thought through. Health and safety is also a key priority - your child needs to be safe!</p>

### Parental Views and Involvement

<p>What support do you have for parents/carers of children with SEND?</p>	<p>We are here for your child and we are here for you! A positive experience for both parent/carer and child is very important to us. If there is anything you want to discuss with us, please come in and make us aware. We will arrange an appropriate time when we can sit down and talk.</p>

	<p>We also offer:</p> <ul style="list-style-type: none"> <li>• Wave 3 planning meetings: For children who have been identified as having additional needs and require SEND support, rather than sharing your child's targets, we would like you to become involved in our discussions/planning and have your say too.</li> <li>• Supportive 'drop in' coffee mornings - this is for parents/carers with concerns, questions or wanting general advice. The aim of these carer/parent advice support group sessions are to share concerns, discuss what works well, things you would like to change and keeping up to date on the SEND systems in the authority. We hope to build a stronger partnership with parents/carers and school working together.</li> <li>• When school seeks advice from outside agencies, parents/carers will be involved in the discussion or have some feedback via reports or meetings in school. These discussions may also offer advice in supporting your child's learning/development at home.</li> </ul>
<p>How and when will I be involved in planning my child's education? Do you offer any parent training or learning events?</p>	<ul style="list-style-type: none"> <li>• Children with complex/higher level of needs will have annual review meetings. This is formal documentation that the SENDCo completes and will involve views from different adults involved in the child's education (including the parents/carers).</li> <li>• As part of our Wave 3 SEND meetings, parents of children with SEND are invited to meet with the SENDCo and class teachers each term to review targets, progress and planning the next steps.</li> <li>• During the drop-in coffee mornings, I am keen to arrange guest speakers - but this will depend on what talks/topics parents would like to hear. As the SENDCo, I can also offer support on topics to parents.</li> <li>• School will have various events throughout the year which parents are invited to. This will help celebrate your child's learning and build stronger community links. We have end of year performances, summer fair, parent workshops etc.</li> <li>• At the start of the school year we offer key information on what to expect in your child's year group. This will help with knowing how to support your child at home. Teachers hold parent workshops to share important information with parents and weekly news/notices are shared on Google classroom as well as via email and letters.</li> <li>• We are always looking for parent/carer volunteers to help out in school. Become part of your child's learning and see how topics are taught! All volunteers are DBS checked (Disclosure and Barring Service).</li> </ul>
<p>What opportunities will there be for regular contact about things that have happened at school? (such as a home school book).</p>	<p>There are various different ways for setting up regular contact, this may be through:</p> <ul style="list-style-type: none"> <li>• Home-school communication diary</li> <li>• Email - there are individual class emails to contact class teachers directly.</li> <li>• Short catch up with the teacher or teaching assistant at the start/end of the day where possible</li> </ul>

How have you made this school accessible to children with SEND?	<ul style="list-style-type: none"> <li>• We ensure that equipment used is accessible to all children regardless of their needs.</li> <li>• All children are included in all parts of the school curriculum and we aim for all children to be included on school trips.</li> <li>• A risk assessment is carried out prior to any off site activity.</li> <li>• There are various ramps to access the school without using steps.</li> <li>• There is also a disabled toilet.</li> </ul> <p>Please also refer to our accessibility plan.</p>		

### Medication and Personal Care

Question			
How does the school manage the administration of medicines and providing personal care?	<p>Please see our Medical Conditions Policy, which will give more detail. We are an inclusive community that aim to support and welcome children with medical conditions. We aim to provide all children with medical conditions the same opportunities as others. Depending on the medical need we may seek outside health services to support us if necessary and provide the staff with training. We feel it is important that the child is encouraged to take control of their condition once they feel confident and supported to do so. Parents/carers will be closely involved with the schools planning for this. Children with a high level of medical needs may have their own IHP (Individual Healthcare Plan) which is reviewed at least annually or sooner if there are changes which needs to be updated in the IHP. This is reviewed with staff, parents and any health care professionals when appropriate.</p>		

## Exclusions and Attendance

### Question

What support is there for behaviour, avoiding exclusions and increasing attendance?

Unwanted behaviour can be a sign of other needs - usually emotional and/or social difficulties. Our aim is to meet the needs of the child, which then reflects on the behaviour. There are various support services/strategies/programmes that can be put in place to help. The last thing we want to do is to exclude as this will not solve the underlying issues. However, we have a duty to keep the child, other children and staff in school safe.

Support may include:

- Support from our ELSA: Emotional Literacy Support Assistant.
- Personalised Learning Plan - time in class, time out, individual lesson plan etc.
- Understanding social situations/social skills, anger management strategies, developing friendships, building self-esteem etc. - programmes and strategies in school.

Any external support will only be provided if you have given consent for their involvement.

Throughout, we will keep regular contact with you through meetings, quick catch up, telephone etc. We recognise that parents/carers also find it a struggle at times with a child displaying unwanted behaviour; therefore, it is important that school and home work together to support the child and we will also make sure there is support for the family when needed. We aim to have a positive, trusting and understanding relationship between school and home.

## Moving On

### Question

How will you support my child when they are leaving this school?

Or moving to another year?

We recognise that transitions can be difficult for a child with SEND and take steps to ensure that any transition is as smooth as possible.

- If your child is moving to another school:
  - We will contact the school SENDCo and ensure he/she knows about any special arrangements or support that need to be made for your child.
  - We will make sure that all records about your child are passed on as soon as possible.
- When moving classes in school:
  - Information will be passed on to the new class teacher IN ADVANCE and in most cases, a planning meeting will take place with the new teacher. All learning passports and previous APDR plans will be shared with the new teacher.
  - Where necessary, a 'welcome' booklet will be given to your child with the key photographs of the staff working with him/her.
- In Year 6:
  - Your child will do focused learning about aspects of transition to support their understanding of the changes ahead.
  - Where possible your child will visit their new school on several occasions and in some cases staff from the new school will visit your child at Priddy & St. Lawrence's Primary School.
  - We will contact the school SENDCo and ensure they know about any special arrangements or support that need to be made for your child.

Our ELSA (Emotional Literacy Support Assistant) can support with transition anxieties.

## Child's Views and Involvement

Child's Views and Involvement	
Question	
<p>Child: How will I be able to contribute my views?</p>	<p>Any strategies put in place will be explained and discussed with you. Your opinion is important and we will ask your views on matters. The SENDCo will share and discuss your targets on your learning passport with you. When it is due to be reviewed, we will discuss it together and reflect on how well you did in achieving the targets. In some cases there may be regular meetings with you to reflect on behaviour e.g. possible causes, consequences. Some children are part of a social/friendship group which is very much an open discussion on given scenarios which looks closely at views/feelings of the child and others around them. Your views are very important to us and help us plan work and strategies to meet your needs. It is also part of knowing what works well for you and what doesn't.</p>
<p>Child: How will I be able to raise any concerns I may have?</p>	<p>Through our positive, caring relationships, we find that if children do have concerns they are happy to approach a member of staff to tell them. We encourage children to talk to us about any worries - that way we are more likely to be able to help!</p>
<p>Child: Who will tell me what I can do to help myself and be more independent?</p>	<p>The work will be organised to meet your needs, you will be able to achieve, but still challenging enough to push you forward in your learning. There may be support mats/displays to help you (i.e. sounds/words for writing), this will support you to become an independent learner which is a key element in becoming successful in your learning. There are other various resources you are encouraged to use if they help you (i.e. number lines, beads, counters). At times children may work in groups, as a whole class, pairs or by themselves. Sometimes the teacher will support you with your work, or the learning support assistant, or even your peers. There will be times when some work will need to be completed without support, which is part of becoming more independent. However, before setting you off to work, you will be taught the necessary skills required for the task.</p>
<p>Child: How will I know how well I am doing?</p>	<p>Feedback can be given in various ways:</p> <ul style="list-style-type: none"> <li>• Verbally (i.e. during work or just general comments during the day)</li> </ul>

- Written (i.e. in books; comments/questions)
- We also have our own marking system; this will include you reflecting upon your work
- Various class tests (spelling etc.)
- Achieving personal/class targets
- Behavioural charts (if used)
- Checking your own work against 'toolkits' (success criteria) check lists

Just ask!

Parents/carers and children's questions were raised by the 'Somerset Parent Carer Forum'. The SEN Information Report was reviewed during the first SEND coffee morning in October 2014 with parents and the SENDCo - this led to further editing, since originally being in place in June 2014. The SEN Information Report was reviewed by Lorraine Clarke (SENDCo) and approved by SEND Governor and Head Teacher - November 2014. The next review took place in December 2015, where parents were also invited in for the review process. This was slightly adjusted to check all criteria was met in May 2016. Feb 2017: this was updated with reference to Core Standards and updated with new SEND Governor details. During the Autumn Term (2016), parents were invited in to discuss. During January 2017, children's views were gathered during Passport discussions and also it was discussed at the SEND staff meeting. The SEN Info report was amended where needed. December 2017: parents were invited in, children's views were continued to be gathered during IEP feedback throughout the year; report was also shared with staff and governor. Updated with stakeholders October 2018. Reviewed in October 2019 - parents invited in or give written feedback. Report shared with Governors/Headteacher and staff for their input. Children's views collected termly. Reviewed with stakeholders Sept/Oct 2020. New SENDCo appointed September 2021 - read and reviewed. Amendments shared with Governors. Autumn 2022 - reviewed and slight changes made to reflect new graduated response. Reviewed Autumn 2023 and updated with link to the Somerset Graduated Response Tool. Reviewed in March 2025 and minor amendments made regarding changes to Local Authority provision.
